

Whai Rawa 10th Birthday prize draw terms and conditions

From time to time Whai Rawa conducts prize draws (Prize Draws).

Note the following:

1. Kā hua o te Kahuru Whai Rawa - celebrating 10 years of success! All Whai Rawa members are automatically in the draw to win!

Between July and September 2016 Whai Rawa will draw prizes for:

- 10 x \$100 Whai Rawa cash vouchers (to be deposited into a Whai Rawa account of your choice)
- 5 x iPad mini's
- 2 x Pounamu (to the value of \$250 each)
- 1 Whānau weekend in Queenstown, including NZ-based internal flights, accommodation, rental car, dinner voucher and whānau pass to the Shotover Jet (2 x adults and up to 2 x tamariki)
- 1 Whānau weekend in Rotorua, including NZ-based internal flights, accommodation, rental car, dinner voucher and whānau pass to Rainbow Springs and the Agrodome (2 x adults and up to 2 x tamariki)

The Whai Rawa cash vouchers will be paid to the open, pending or 'incomplete' Whai Rawa account of the winner and no alternative payment method is available. Open account is the definition used in the Whai Rawa Prospectus, at 6.7 – 6.14.

Winners of the whānau weekend in Queenstown or Rotorua are required to redeem their prize by November 2016.

2. The Promotional Period for the Whai Rawa 10th Birthday prize draw is from 21 July 2016 to 30 September 2016.
3. The closing dates per Prize will be calendar monthly during the 3 months of Promotional Period as directed in point 2 above.
4. The winner of a Prize Draw will be notified by email (at the email address provided on registration, as updated from time to time, with Te Rūnanga o Ngāi Tahu) or by telephone, or by post on the contact number provided on registration, as updated from time to time, with Te Rūnanga o Ngāi Tahu).
5. If Whai Rawa is unable to contact the winner within one week of the Prize Draw the winner's entry will be declared invalid and the Prize forfeited. If so, Whai Rawa reserves the right to redraw another winner on the same terms and conditions as the original draw.
6. The winner of the Prize Draw will not incur costs in order to collect the prize.
7. Whai Rawa reserves the right to request proof of registration, payment and/or membership (if applicable) from a person claiming a Prize.
8. There is no entry fee or ticket for the Prize Draw.
9. All entries become the property of Whai Rawa and may be used for promotional and marketing purposes, or passed onto a third party for their marketing purposes.
10. Winners agree to the use of their name and photograph(s), by Whai Rawa and Te Rūnanga o Ngāi Tahu, for publicity and promotional purposes, without compensation. Whai Rawa will own copyright in any such photograph(s) and in all material incorporating the photograph(s).

11. Prize draw winners will be listed on www.whairawa.com and other social media. Hence, your name and location may be published at www.whairawa.com, and groups associated with Whai Rawa if you are a winner.
12. Prizes are not transferable or exchangeable for cash. In the event that a Prize becomes unavailable for reasons beyond Whai Rawa's control, Whai Rawa may substitute a prize of equal value.
13. Employees of TRONT or any of its subsidiary entities, TRONT Representatives or employees of any company involved in the Prize Draw, or any advertising agency or web company connected with the Prize Draw or any such persons subsidiary or associated companies, agents or members of their families or households, are not eligible to enter the Prize Draw.

Neither Whai Rawa nor any other person associated with a Prize Draw shall be liable for any loss or damage whatsoever suffered (including but not limited to indirect or consequential loss or loss of profits and including loss caused by negligence) or personal injury suffered or sustained in connection with either participation in a Prize Draw or the use of any Prize offered, except for any liability which cannot be excluded by law.

16. Whai Rawa reserves the right to cancel or amend these terms and conditions at any time without prior notice. Any changes will be deemed to be incorporated into these terms and conditions.
17. Whai Rawa's decision in relation to any aspects of a Prize Draw is final and binding on every person who enters and no correspondence will be entered into.
18. If the prize entails payment is to be made into an open Whai Rawa account, a pending Whai Rawa account or 'incomplete' Whai Rawa account. payment must be made into any open Whai Rawa account within 6 months of the Prize Draw closing, or accounts, no cash alternative will be offered.
